

What happened in the 2013 Minnesota state legislative session?

As it does following each legislative session, Minnesota Family Council tracked and scored legislators' votes on a number of issues affecting Minnesota families to show how they measure up to our pro-family principles. The issues scored range from the redefinition of marriage and excluding abortion from health benefit plans to a \$2.1 billion tax increase — the largest in our state's history and the equivalent of a \$1,600 tax increase on a family of four.

In addition to marriage and taxes, MFC scored votes on establishing a state health care exchange, protecting the rights of conscience of health care workers, parental rights protections, mandating social engineering training for all public schools under the guise of "anti-bullying," and unionizing child care providers.

In many respects this was one of the most radical, most aggressive legislative sessions to expand the role of the state in the lives of Minnesotans and change the values and priorities of our state from the top down.

In our scorecard we highlight twelve votes in both the House and Senate and show how your legislator voted and whether each vote was pro-family or anti-family. We then tally the votes by individual legislators and calculate their overall score.

We highlight eighteen state senators and forty-five state representatives as "Champions of the Family" for 100 percent pro-family voting records on these critical issues. (It should be noted that some family-friendly legislators didn't receive 100 percent if they failed to vote on one or more issues.)

What can you do?

First, we encourage you to review how your legislators voted and contact them. Either thank them for their pro-family votes or ask them why they voted against the family. You can find out who your legislator is and how to contact him or her by going to the legislative district finder at the MFC Action Center, https://www.voter-voice.net/MNFC/Home.

Second, inform others of where your current elected officials stand on the issues by forwarding this 2013 Legislative Scorecard. You can also go to our Action Center and download a PDF version of the voter's guide.

And finally, don't forget to pray for all our elected officials. As the Apostle Paul writes in 1 Timothy 2:1, "First of all, then, I urge that entreaties and prayers, petitions and thanksgivings, be made on behalf of all men, for kings and all who are in authority, so that we may lead a tranquil and quiet life in all godliness and dignity."

Pray, too, that God would be merciful and provide our state with leaders who meet the biblical criteria of Exodus 18:21, those who are able, fear God, are truthful, and hate dishonest gain.

- 1. Legalize Homosexual "Marriage": A vote to legalize homosexual "marriage" in Minnesota. MFC opposed this bill. (2013 Senate Journal, p. 3584)
- Provide Religious Liberty Protection in New Marriage Law: A vote to protect the religious liberties of persons and organizations who object to providing goods, services and facilities to perform, celebrate, affirm or sustain same-sex "marriages" based on deeply held religious beliefs. MFC supported this amendment. (2013 Senate Journal, p. 3583)
- 3. Keep "Man" and "Woman" in Marriage Statute: A vote to keep "man" and "woman" references in marriage statute for marriages between opposite sex persons. MFC supported this amendment. (2013 Senate Journal, p. 3584)
- 4. Pass Anti-Bullying Provisions Without Re-Education Components: A vote for policies and procedures for addressing all forms of bullying in public schools without requiring training and re-education on sexual orientation, gender identity and other characteristics.
